### 1. IDENTIFICATION OF THE SUBSTANCE

### 3. HAZARDS IDENTIFICATION

#### Emergency Overview

- May cause mild eye and skin irritation.
- Mildly harmful if excessive quantities have been ingested.

#### Potential Health Effects

##### Inhalation:

May cause irritation to respiratory system if mists or sprays inhaled

##### Ingestion:

Ingestion of this product may irritate the gastric tract. May cause diarrhoea, nausea, vomiting and cramps if ingested.

**Skin Contact:**

Prolonged contact may cause irritation or allergic dermatitis

**Eye Contact:**

This material maybe irritating to eyes. Eye protection necessary during application

**Chronic Exposure:**

None observed where product is used under conditions of good industrial hygiene.

**Aggravation of Pre-existing Conditions:**

No information found.

#### **4. FIRST AID MEASURES**

**Inhalation:**

Remove from exposure to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen. Keep person at rest and warm. Treat symptomatically and supportively as and when required. Obtain medical advice if necessary.

**Ingestion:**

Have victim rinse mouth thoroughly with water. Give 1/2 to one glass of water or milk to dilute the material if victim is alert and not convulsing. Do NOT induce vomiting. If spontaneous vomiting occurs, have victim lean forward with head down to avoid breathing in of vomits, rinse mouth and administer more water. Never give anything by mouth to an unconscious person. Seek medical advice immediately.

**Skin Contact:**

Remove any contaminated clothing. Wash skin with soap or mild detergent and water for at least 15 minutes. Get medical attention if irritation develops or persists. Wash clothing before re-use.

**Eye Contact:**

Immediately flush eyes with cold water for at least 15 minutes, lifting lower and upper eyelids occasionally. Do NOT allow victim to rub or keep eyes closed. Get medical attention immediately.

**Note to Physician:**

Treat symptomatically and supportively.

#### **5. FIRE FIGHTING MEASURES**

**Fire:**

Not considered to be a fire hazard. Advise fire brigade of any hazard. Suitable for most extinguishing media.

**Fire Extinguishing Media:**

Extinguish with water spray, carbon dioxide, foam, and dry chemical.

**Special Information:**

In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full-face piece operated in the pressure demand or other positive pressure

mode. Fire may produce irritating or poisonous vapours, mists or toxic gasses.

## **6. ACCIDENTAL RELEASE MEASURES**

Ventilate area of spill. Avoid breathing dust. Clear the affected area and protect people. Wear appropriate personal protective equipment as specified in Section 8.

**Small Spills:** Wash away with plenty of water. Do not contaminate waterways, sewers basements or confined areas.

**Large Spills:** Pick up and place in a suitable container for reclamation or disposal, using a method that does not generate dust. Following product recovery, flush area with water. Do not contaminate waterways, sewers, basements or confined areas. Place all spill residues in an appropriate container and dispose of in accordance with local regulations.

## **7. HANDLING AND STORAGE**

**Handling:**

Wash thoroughly after handling. Do not get in eyes, on skin or on clothing. Do not ingest or inhale. Use with adequate ventilation. Observe all warnings and precautions listed for the product.

**Personal protection:**

Protective equipment must be worn: PVC gloves, waterproof apron, safety boots and a full-face shield. Avoid breathing dust or vapours.

**Flammability:**

The product poses no flammability hazard.

**Storage:**

Keep in tightly closed container in a shaded, well-ventilated area, away from heat, sparks and other sources of ignition. Protect against physical damage and frost. Do not contaminate water, food, or feed by storage or disposal.

## **8. EXPOSURE CONTROLS/PERSONAL PROTECTION**

**Ventilation system:**

In general, dilution ventilation is a satisfactory health hazard control for this substance. Always ensure that the ventilation is adequate in order to maintain the air concentrations below the exposure standards and as low as reasonably possible. However, if conditions of use create discomfort to the worker, a local exhaust system should be considered.

**Skin Protection:**

Wear suitable personal protective equipment i.e. overalls, rubber gloves and boots.

**Eye Protection:**

Use chemical safety goggles and/or full-face shield where splashing is possible. Maintain eye wash fountain and quick-drench facilities in work area.

Respiratory:

It is recommended that a dust mask must be worn when handling this product.

Stability:	Stable under ordinary conditions of use and storage.
